CALL FOR ABSTRACTS

The International Cooperative Alliance Committee on Cooperative Research (ICA CCR) EUROPE Research Conference will be held online on 7-8-9 July 2021.

The ICA CCR Europe 2021 Conference will deepen the understanding of the resilience of cooperatives facing crisis. How does the cooperative movement contribute to sustainable and solidarity societies? How do cooperatives anticipate and respond to new business opportunities and develop innovative solutions for a sustainable and solidarity future? How do we characterize the democratic work of cooperatives and their impact, from the point of view of organizations, territories, and emancipation? The Conference will explore how cooperatives address current global issues and challenges, such as improving sustainable development, reducing income and wealth inequality, enhancing gender equality and offering a future with decent work. The competitive advantage of cooperative democracy, business performance, market share, best governance and digital capabilities will also be explored.

Moreover, the ICA CCR Europe 2021 Conference offers a unique opportunity to celebrate the 100th anniversary of the International Review of Social Economy or Recma (http://recma.org). Founded in 1921 by Charles Gide and Bernard Lavergne, the Recma is today one of the oldest peer-reviewed journals dedicated to works on cooperation and social economy.

The ICA CCR Europe 2021 Conference will explore and address specific themes intrinsically linked to the overarching theme of the Congress: "Cooperatives in transitions facing crisis".

ABSTRACT SUBMISSION AND PROPOSALS OF PANEL SESSION

All abstracts must be submitted through the online platform:

Submitted abstracts should be 1,000 words maximum and should include:

- Title, author(s) and affiliation(s)
- Theme of the submission and sub-theme (see above) **or** the name of the panel session in which you are invited
- Core idea/ arguments / methodology and results as well as at least 5 bibliographic sources
- 3 to 4 keywords

Young Scholars (students, or scholars within 2 years of graduation) are particularly encouraged to submit proposals and participate to the Young Scholars Event on the 7 July 2021.

The authors of the selected abstracts will be invited to develop them into full papers (5000-7000 words). They will interact with the scientific committee in order to elaborate their papers in line with the Congress program. The best papers will be selected for presentation in relevant sessions of the Congress, and/or publication.

Proposals of panel session

Evaluation and selection will be made on the basis of the potential of the proposed communications and panel sessions to address critical issues in mobilizing relevant and robust arguments based on theoretical, analytical, conceptual and/or empirical bases.

Language: English is the default language for the conference.

Written content (abstracts, slides, and full papers) needs to be in English.

Publication: All abstracts will be integrated into a conference book online. All papers will be uploaded on the Conference website and app. Presenters (paper and/or panel) will be emailed a signed certificate from the host organization and ICA CCR Europe confirming the presentation of their scientific work at the conference.
