1. The Bernard Maris UNESCO Chair offers a Post-Doctoral Fellowship

Sciences-Po Toulouse hosts the Bernard Maris UNESCO Chair, which offers a **18 months** post-doctoral fellowship from January **1**, **2024 to June 30**, **2025**. The post-doctoral fellow will be affiliated to the LEREPS research unit, and will work in collaboration with the holder of the Chair, Prof. Ron Boschma (Universities of Utrecht and Stavanger), and with Profs. Olivier Brossard and Jérôme Vicente (Sciences-Po Toulouse, University of Toulouse). She will work in Toulouse, with the possibility of making stays in Utrecht.

2. Research topics

The post-doctoral fellow will conduct her research project on one of the following topics:

- Regional and urban aspects of the green transition
- Smart strategies for regional resilience
- Economic geography of the green technological transition
- Economics of innovation and economic geography
- Entrepreneurship, institutions, and geography of innovation
- Regional diversification and green transition
- Finance and innovation for a greener economy

Her work will aim to carry out one or more scientific publications in collaboration with LEREPS researchers

3. Sciences-Po Toulouse

- Ability to work independently and as part of a team
- Strong academic writing skills and experience
